INSTRUCTIONS: Registration of C&D Debris Recycling Facility Form

Reason for Registering

On May 3, 2018, Section 44-96-360 of the S.C. Solid Waste Policy and Management Act was amended to establish certain conditions for facilities that recycle construction and demolition (C&D) debris. Any facility in operation **prior to May 3, 2018** must register with DHEC **no later than July 3, 2018**. All other C&D debris recycling facilities must register prior to starting operations.

Who must file a Registration of C&D Debris Recycling Facility? Anyone who accepts mixed or sourced separated C&D material for the purpose of recovering materials for use or reuse, such as concrete, asphalt, bricks, wood, plastic and etc.

Completing the Form

You must type or print all information. The instructions on this page should be of assistance in completing the Registration for C&D Debris Recycling Facility form. If you still have questions about completing this form, DHEC's Solid Waste Permitting staff is available to provide assistance or answer any questions at swpermitting@dhec.sc.gov.

SECTION I: Contact Information

Name of Applicant – Provide the full name (first name, middle name and last name) and title.

Mailing Address – Provide the county the site is to be located, complete mailing address (street number or PO Box, street name, city, state and zip code) and telephone number.

Contact Person – Please provide the name and title of the person serving as the contact for the facility as well as their telephone number and email address. If ownership is by more than one person or by a corporation or other legal entity, provide the name, title, mailing address, telephone number and email address of the legal representative (i.e., one who has authority to approve use of the affected property for the proposed activity).

SECTION II: Facility Information

Name of the C&D Debris Recycling Facility – Provide a unique and descriptive name for the facility. This name shall be used in all future correspondence with DHEC.

Site Address – Provide a physical site address for the location of the proposed facility including the county name, street number, street name, city, state and zip code. If the site lacks a physical address, provide directions to the site using U.S., state or county highway numbers, intersecting highway, names of the nearest town or city and distances in miles.

Tax Map Number – Provide tax map numbers for all tax parcels to be affected by the proposed site.

Acreage of Property: Please provide the number of acres of land on which the entire facility occupies.

Latitude and Longitude or UTM Coordinates – Provide geographical coordinates [latitude/longitude or Universal Transverse Mercator (UTM)] for the approximate center of the proposed C&D debris recycling facility. Accuracy of coordinates should be to the nearest 0.01 second for latitude/longitude, or to the nearest 0.1 meter for UTM.

Coordinates Obtained Using – Describe method for obtaining coordinates (e.g., hand-held GPS instrument, GIS software such as ESRI ArcMap or Google Earth mapping service, U.S. Geological Survey 7.5-minute Topographical Map).

SECTION III: Material Collected
